Some 10 years after the financial crisis plunged world economies into the Great Recession, the U.S. macroeconomy has regained much of its strength and resilience, with unemployment low and recent growth strong. However, the path forward is unclear, as trade policy and government shutdowns contribute to volatile markets and some but not all analysts see a recession possible in the not-too-distant future. The agricultural economy has seen pockets of persistent weakness, affecting not only some farmers but their suppliers, lenders and others as well, and has suffered collateral damage from ongoing trade disputes.
