INTRODUCTION

The Executive Council of the International Dairy Foods Association (IDFA) fully subscribes to the letter and spirit of the federal antitrust laws and to the principles of free and open competition upon which these laws are based. The Executive Council is committed to the proposition that all meetings and other activities of IDFA are held in such a way as to assure strict compliance with requirements and prohibitions of the antitrust laws, and to avoid even the appearance that any Association activity might raise a question under the antitrust laws.

This brochure is designed to assist all members, officers, participants and staff in gaining a general insight into certain federal antitrust principles that are applicable to the day-to-day business and activities of IDFA. It would be virtually impossible to catalogue all of the Associations' activities or forms of conduct which might fall within the scope of antitrust laws, since the laws themselves are stated in very general terms, and the factual circumstances that may give rise to an antitrust violation are so varied.

Nevertheless, because the IDFA believes that it is imperative to articulate, at least in broad terms, the basic principles which we follow in conducting the Associations' business, we have published this brochure in the hope that it might offer some general guidance. This brochure does not, however, purport to be an exhaustive statement of principles; it is instead a general overview of applicable policies and is designed to be amended or updated as circumstances arise.

BASIC PRINCIPLES OF IDFA ANTITRUST POLICY

Prohibited Topics for Discussion

IDFA will not, knowingly, allow any discussion among members at any Association meeting or in any Association communication, of selling prices, discounts, freight allowances, terms of warranties, other terms-of-sale or acquisition costs, apart from discussion concerning government programs relating directly to those areas. Other topics of discussion that are not permitted at meetings include: sales or production quotas, sales territories, allocation of customers or products, boycotts, refusals to deal, market sales or reciprocal dealing. These rules apply equally to members that are agricultural cooperatives, whose exemption from the antitrust laws under the Capper-Volstead Act does not extend to their dealings with independent processor companies.

Review by Counsel

All directions given or actions taken by the Executive Council, Industry Segment Boards or committees of the Association are subject to review and approval by counsel, in order to assure compliance with antitrust and other legal requirements.

Terms of Membership

IDFA will not deny membership to any person or firm where trade might be unlawfully restrained as a result thereof nor will a member be expelled for reasons that would be insufficient to justify the denial of membership in accordance with IDFA's Bylaws.

Data Reporting

Whenever IDFA becomes involved in the reporting of statistical data relating to their respective industries, the data will be designated to provide appropriate information that will assist members in making business decisions. Participation in any statistical reporting programs will always be on a voluntary basis. Any data provided will pertain to past, rather than present or future, transactions and will be reported in aggregate form so as not to permit identification of the terms of any specific transactions or the terms offered by any specific firm.

Research Activities

In any collective research activities undertaken by IDFA, care will be taken that the research activities do not, in any way, restrain competition.

Independent Decisions

IDFA will not sponsor, approve or knowingly be a party to any agreements, whether expressed or implied, which in any way restrict members' freedom to make independent, competitive decisions. Consultation with Staff and Counsel Questions about IDFA's programs or activities can be freely discussed with Associations staff and counsel. Members are, of course, always free to consult their own counsel concerning the Associations' programs or activities.

CONCLUSION

Penalties for violations of federal antitrust laws can be quite severe, reflecting the serious nature of these matters. A company that violates the Sherman Act faces a criminal fine of up to \$10 million, twice the monetary gain the company derived from the violation, or twice the loss caused to customers by the violation, whichever is greatest. An individual who violates the Sherman Act faces up to three years in prison. While it is impossible, as a practical matter, to cover every contingency that might arise under the antitrust laws, it is essential that everyone attending Association meetings have at least a basic understanding of federal antitrust laws and their possible applications to IDFA programs and activities. We commend these principles to you as part of our basic commitment to the concept that competition is the lifeline of a healthy and continuing industry.

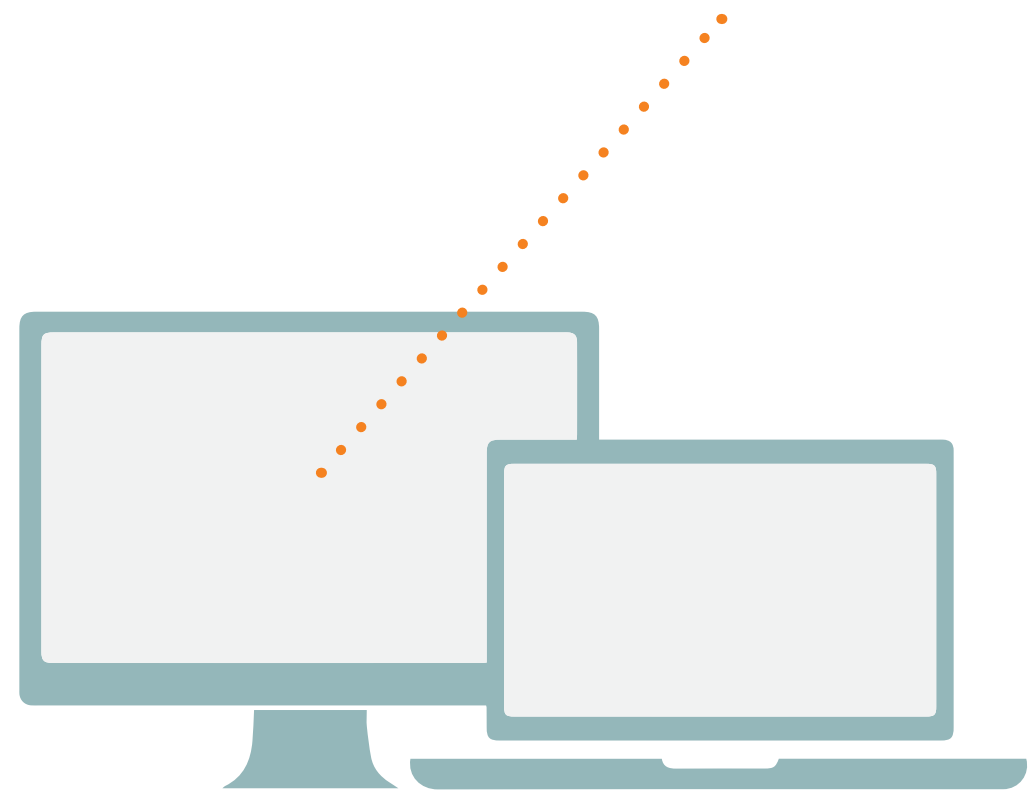
