Dear Leaders in the Ohio Legislature:

On behalf of dairy producers, processors, suppliers, truckers, wholesalers and retailers in the state of Ohio and across the United States, the members of the International Dairy Foods Association (IDFA) strongly oppose SB161. This bill, introduced in the Ohio Senate, would unfairly restrict the use of SNAP benefits for purchasing America-grown, American-produced milk, dairy and dairy products - harming both Ohio families and the state's dairy industry

To avoid any unintentional disruption to Ohioans' access to dairy nutrition, and to prevent economic harm to the dairy farming families and dairy processors in your state, we urge you to include the following language in any legislation that seeks to restrict the use of SNAP benefits on certain foods:

"No federal waiver request made to the U.S. Department of Agriculture shall seek authorization to prohibit the use of SNAP benefits for the purchase of any food or beverage that contains milk, milk products or milk proteins."

Dairy foods are essential to public health. Unlike the products this legislation seeks to limit, milk and dairy products provide 13 essential nutrients, including three of the four nutrients identified as most critical to public health—calcium, vitamin D and potassium. Dairy plays a critical role in the diet of children, where milk and dairy are the top source of calcium, potassium, phosphorus, and vitamin D in kids ages 2-18. No other food or beverage provides the same unique combination of nutrients and health benefits including better bone health and lower risk for type 2 diabetes and cardiovascular disease. Any restriction on milk, dairy, or milk-containing products stands to negatively impact the health of Ohioans, which is contrary to the goal of this legislation.

SB161 sets a dangerous precedent by unfairly targeting ice cream—a dairy product with real nutritional value. Ice cream contains essential nutrients such as calcium, vitamin D, vitamin A, vitamin B6, and vitamin B12. It also contains healthy fats that help the body absorb essential nutrients and support energy. If Ohioans are looking for a treat, let's encourage options that deliver both enjoyment and nourishment too. By unfairly and incorrectly lumping ice cream in with empty-calorie foods, this legislation disregards the contributions of more than 1,400 dairy farms and 65 dairy processing facilities across the Buckeye State.

IDFA represents the nation's dairy manufacturing and marketing industry, including 22 companies headquartered in the state of Ohio. Our industry is critical to the economic vibrancy of Ohio, supporting 45,000 jobs, \$12 billion in direct wages, and \$35 billion in total economic impact. Importantly, every gallon of milk, block of cheese, or pint of ice cream purchased through SNAP directly supports the milk produced on Ohio dairy farms, processed by Ohio workers, and delivered to grocery stores nationwide.
